- Photo Identification at least one of the following drivers licence, passport or photo ID
- Proof of Income your most recent payslip, letter of offer stating your income, contract or if you are self employed please provide details of your accountant and a copy of your latest tax assessment
- Rental Reference if your rental reference is an Agent you will need to obtain a copy of your tenant ledger and attach it with your application. If your rental reference is a private landlord you must provide proof of tenancy, i.e copy of your lease and a written reference. If you are a current home owner you are required to provide proof of ownership i.e a copy of your most recent rates notice
- The property will remain on the market until a lease has been signed and initial rent has been received.
